The Wilmington St Patrick's Day Parade Bus Routes Detour Notice - The annual St Patrick's Day Parade will be held on Saturday, March 13th. All DART bus routes will be on detour from 10 AM to 2 PM. ALL ROUTES WILL STOP AT ALL STOPS ON ORANGE STREET. Boarding notices will be posted at the following bus stops: 10th at Market, Routes 2, 6, 10, 11 & 12, board on Orange at 9th or 10th Street; King at 10th, 9th, 8th, 6th & 5th, Routes 2, 4, 5, 6, 9, 10, 11, 12, 15, 17, 22, 23, 24, 25, 33, 40, 54 & 55, board on Shipley between 9th & 8th; 11th at King, Routes 1, 3, 9 & 24, board on Shipley between 9th & 8th; 8th at Shipley, Routes 3 & 8, board on Shipley between 9th & 8th; 9th at Market, Route 8, board on Shipley between 9th & 8th; 4th at Shipley, Routes 4, 5, & 24; board on Shipley at 4th; Walnut at 5th, Routes 2, 6, 10, 11 & 12, board on 2nd at French (Routes 1, 3, 9 & 24 will be stopping here continuing on Walnut to 16th); French at 9th, Routes 2, 6, 10, 11 & 12, Board on Orange St. at 9th or 10th; Orange at 10th, Route 33, board on Shipley between 9th & 8th St.

SEPTA R2 Schedule Adjustments – Two important changes for R2 train customers riding weekday train #9223 towards Wilmington, effective March 8th this train is now train #4223. Train times have been adjusted to depart stations 11 minutes earlier than shown in the January 17th printed timetable.
