

Flex Service

The three Flex Routes provide service within Georgetown, between Georgetown and Millsboro, and within Seaford, and offer:





- 1) Regularly scheduled service to established bus stops.
- 2) Off-route curbside pick-ups/drop-offs available to everyone within one mile of the regular route on a space/time available basis. This option is available by calling 1-800-652-3278, option 3 a minimum of 2 hours or up to 2 days ahead, and only costs \$1.00 per trip.
- 3) Flag Zones are areas where a customer can wave down the bus to stop (see shaded listings). The driver will determine the safest stop location within the approved zone.


Servicio Flex

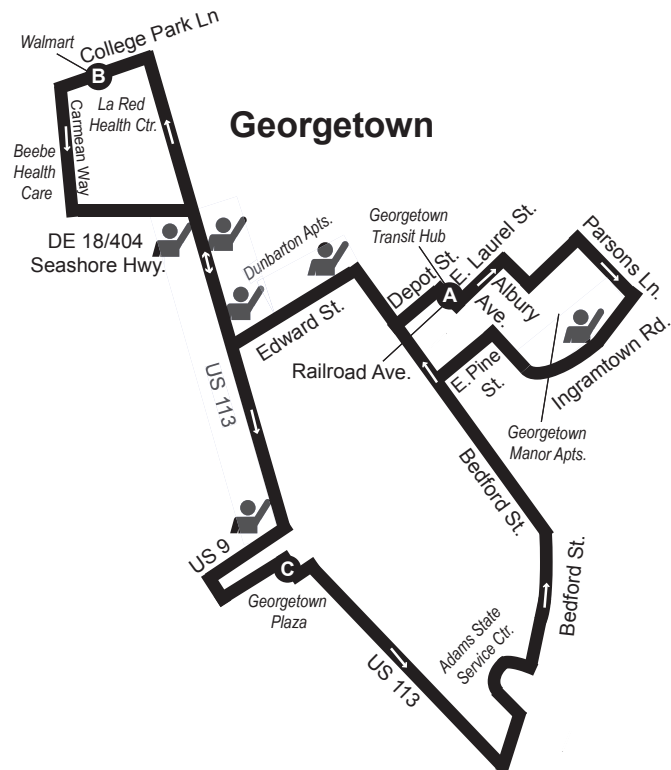
Las tres Rutas Flex proveen servicios dentro de Georgetown, entre Georgetown y Millsboro, y dentro de Seaford. Estas ofrecen:

- 1) Servicio con horario regular en paradas designadas.
- 2) Recogidas y bajadas en la acera fuera de la ruta están disponibles para todos dentro de una milla de la ruta normal cada vez que haya disponibilidad de tiempo y espacio. Esta opción está disponible llamando al 1-800-652-3278, opción 3 un mínimo de 2 horas o hasta 2 días antes, y solo cuesta \$1.00 por viaje.
- 3) Las Zonas "Flag" son áreas donde el cliente puede parar el autobús con la mano (ver listados resaltados con gris). El conductor decidirá el lugar más seguro para detenerse dentro de la zona aprobada.

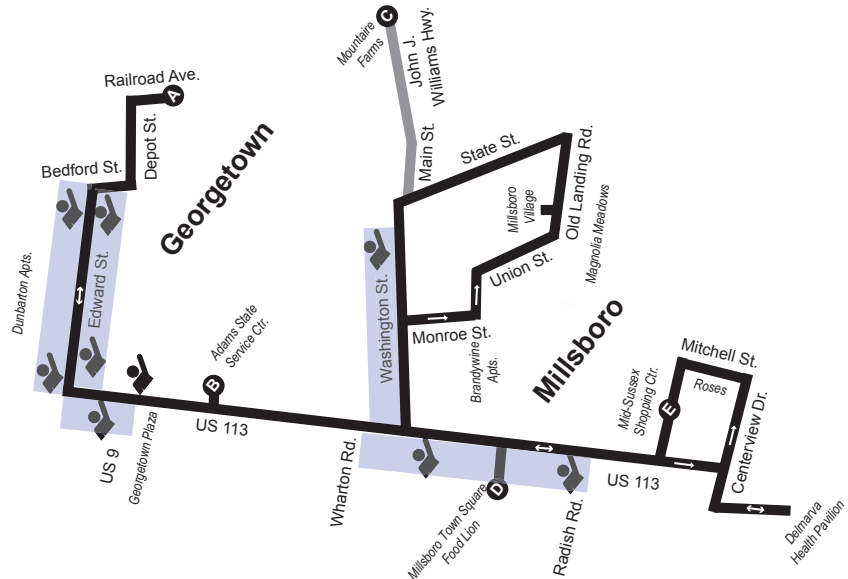

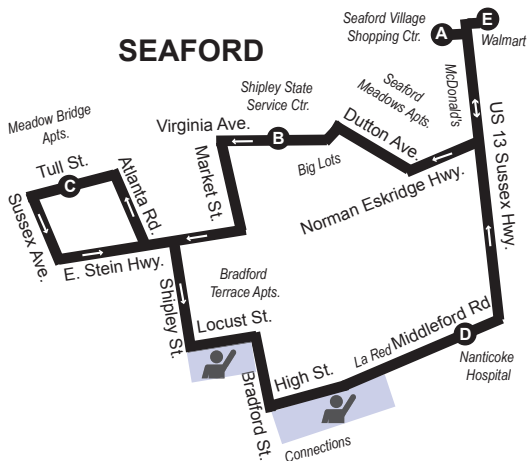
