## **DTC Updates:**

DART Fleets will transition to a fully DART Pass system, phasing out traditional tickets and implementing direct billing for users without the mobile app.

DTC anticipates the arrival of eight cutaway buses in late fall for use in New Castle County. Additionally, four 29-foot diesel buses are scheduled for Sussex County in February 2025. DTC will also receive eight hydrogen fuel cell buses for New Castle County in 2026, along with two additional battery electric buses for Sussex County in FY26.

DTC is proud to celebrate Paratransit Services in Delaware.

In 2025, DTC will have our new software implemented. Transitioning from Trapeze to our new Queue Ride software. We expect this new technology to greatly enhance our on-time performance.

The Queue Ride system includes a shuffle trip feature designed to manage same-day cancellations, which will help address issues related to operators facing excessive downtime or delays. Overall, the new software aims to optimize our daily operations by redistributing trips more effectively.
